(2) From Sealdah to Jalpaiguri Road Station via Raninagar (in case of Torsha)
- Kamrup Express: : From Howrah to Jalpaiguri Road Station.
- Darjeeling Mail / Kanchankanya / Padatik Express: From Sealdah to New Jalpaiguri (NJP), from NJP to Jalpaiguri Govt. Engg. College by road.

5. Hostel Facilities (Boys & Girls):
