Sub: - Extension of Autonomous Status to Jalpaiguri Govt. Engineering College, Jalpaiguri, West Bengal-735 102 affiliated to Maulana Abul Kalam Azad University of Technology, West Bengal

Sir/Madam,

This has reference to the proposal submitted by Jalpaiguri Govt. Engineering College, Jalpaiguri, West Bengal-735 102 affiliated to Maulana Abul Kalam Azad University of Technology, West Bengal for extension of autonomous status under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 12.04.2021, the Competent Authority has decided to extend the autonomous status to **Jalpaiguri Govt. Engineering College, Jalpaiguri, West Bengal-735 102** affiliated to **Maulana Abul Kalam Azad University of Technology, West Bengal** for a period of Five (05) years from the session 2021-2022 to 2025-2026 Including ex-post-facto approval for the period 2018-2019 to 2020-2021, as per provisions of Clause 3.13 and Clause 6.3 of UGC Regulations dated 12.02.2018.

The University is requested to issue necessary notification/order regarding extension of autonomous status to the College as per the UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The College, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The Autonomous College is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugu.ac.in. Non compliance of the requirements and conditions in the said Regulations shall attract action as per Clause -14 of the UGC Regulations – 2018. Further, it may be noted that the above said college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.

Further, your attention is invited to the clause 6.3 of UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 as given below:



"The colleges must be accredited by either NAAC with minimum 'A' Grade or by NBA for at least three programme(s) with a minimum score of 675 individually or a corresponding accreditation Grade/score from a UGC empanelled accreditation agency. However, if the number of programme(s) being run by the Institution is less than three, then each of the programmes should secure 675 or more marks. Accreditation status must be valid at the time of application.

Provided further, the existing autonomous colleges will be required to comply with this eligibility condition by 11th February, 2023 as per Clause of 6.3 of UGC, Regulations 2018.

The college is requested to take necessary action accordingly.



The autonomous status for the period of five (5) years w.e.f.2021-2022 to 2025-2026(including ex post facto period of 2018-2019 to 2020-2021) under THE WEST BENGAL UNIVERSITY OF TECHNOLOGY ACT, 2000 (West Bengal Act of 2000) subsequently amended vide Government of West Bengal, Law Department, Legislative Notification No. 487-L- 6th April, 2015 with the substitution of the words “Maulana Abul Kalam Azad University of Technology, West Bengal” is conferred to

JALPAIGURI GOVERNMENT ENGINEERING COLLEGE, JALPAIGURI, West Bengal – 735102

The above autonomous status is being issued subject to fulfillment of the following terms and conditions:

1. That the deficiencies / suggestions as pointed out by the UGC Committee in its report and as has been referred to in the UGC letter No. F.22-1/2017(AC) on the subject “Extension of Autonomous Status to Jalpaiguri Government Engineering College....” Dated 19th May, 2021 issued by Joint Secretary, UGC shall have to be complied / implemented (respectively) as early as possible by the College Authorities.
2. That the admission in courses is to be made strictly in accordance with the yearly affiliation letter as will be issued by the University.
3. That the admission, registration, etc., shall be made in accordance with the regulations as will be notified by the University from time to time.
4. That issuance of no excess marksheet / certificate beyond admission / university registration shall be made by the college under any circumstances.
5. That the college shall operate only from the above approved location / address.

That this University may conduct special visits for observing the maintenance of quality of education. In case of non-compliance resulting sharp decline in standards and or/ quality and /or guidelines in the autonomous college, it shall be open to this university to revoke the autonomous status of the college and inform UGC accordingly.

As Jalpaiguri Government Engineering College is a solely owned Government college, the necessary autonomy fee admissible for the period comprising from 2021-2022 to 2025-2026 is being waived.
