MEMORANDUM OF UNDERSTANDING
BETWEEN

JALPAIGURI GOVERNMENT ENGINEERING COLLEGE, JALPAIGURI

AND

PRASANNADEB WOMEN'S COLLEGE, JALPAIGURI

This Memorandum of Understanding (hereinafter referred to as "MOU") is made on 3rd Day of April, 2024

WHEREAS, this MoU is of a generic nature for Academic collaboration, Student and Faculty Exchange Programmes, Training Programmes, Internship Programmes, Faculty Development, Joint conference etc.

A. OBJECTIVES

- To foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best effort, mutual benefit, and frequent interactions.
- To identify and pursue joint research & development projects, including those related to innovation and creativity, between Jalpaiguri Government Engineering College and Prasannadeb Women's College leading to publications, patents, copyrights etc.

- c) To exchange, on a reciprocal basis, students at Undergraduate for limited periods of time for purpose of education.
- d) To Mentor Under-Graduate students of **Jalpaiguri Government Engineering College** for successful completion of their internship/project at **Prasannadeb Women's College** To exchange information on teaching, learning material, plagiarism issues and other literature relevant to their educational and research programmes.
- e) To jointly propose and engage in research or training programmes sponsored by funding agencies, and to invite each other's faculty to participate therein.
- f) To utilize facilities & expertise as per the requirements of respective parties on mutually agreed terms and conditions on case-to-case basis.
- g) To jointly organize seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty/employee/experts to participate therein.
- h) To jointly organize placement drive/Skill development program etc.

B. FINANCIAL ARRANGEMENT:

Jalpaiguri Government Engineering College and **Prasannadeb Women's College** agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two parties in writing. These terms shall include a technical description of proposed activity, financial arrangements, and person(s) responsible for its implementation, etc. As such this MoU has no financial implication on each other.

C. CONFIDENTIALITY AND INTELLECTUAL PROPERTY

Jalpaiguri Government Engineering College and **Prasannadeb Women's College** to respect each other's rights to intellectual property. Further, the Intellectual Property Rights (IPR) that arises as a result of any collaborative research or activity under this MoU will be worked out on a case-to-case basis, and will be consistent with officially laid down IPR policies of the two parties.

D. TENURE AND TERMINATION

This MoU will take effect from the Effective Date upon signatures by representatives of the two parties. It will remain valid for five (5) years, and may be extended further by the parties in writing. The MoU may be terminated by either party with notification to the other of its intension to terminate MoU.

Either party may terminate the MoU by giving written notice to the other party six months in advance. Once terminated, neither **Jalpaiguri Government Engineering College** nor **Prasannadeb Women's College** will be responsible for any losses, financial or otherwise, which the other party may suffer. However, **Jalpaiguri Government Engineering College**



and Prasannadeb Women's College will ensure that all activities in progress are allowed to complete successfully.

E. ARBITRATION CLAUSE

Should there be a dispute relating to any aspect of research and cooperation, the Principal, Jalpaiguri Government Engineering College and the Principal, Prasannadeb Women's College will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

This MoU is prepared in two identical copies. Each party holds one original copy duly signed by the Principal of Jalpaiguri Government Engineering College and the Principal of Prasannadeb Women's College.
